2) ORGANISATION AND STATUS

- a) The Event shall be held under the FIA International Sporting Code including Appendices, the National Competition Rules of the Confederation of Australian Motor Sport Limited (CAMS), the Race Meeting Standing Regulations, the NSW Motor Race Championship Sporting Regulations as approved by CAMS, these Supplementary Regulations and any Further Regulations and instructions to Competitors that may be issued.
- b) The Event shall be a NSW State Motor Race Championship Meeting, with races for the invited;
- c) This Event will be conducted under and in accordance with CAMS OH&S, CAMS Safety 1st and Risk Management Policies, which can be found on the CAMS website at www.cams.com.au.

- d) Entries shall be accepted in order of receipt.
- e) The Organiser reserves the right to refuse entry to any Competitor in accordance with NCR 83.

7) EVENTS

Races will be conducted for vehicles complying with Regulations for the following categories as outlined in the 2019 CAMS Manual of Motor Sport and 2019 CAMS NSW Motor Race Championship Sporting Regulations and appendices:

Formula Cars (38), Formula Ford (47), Sports Sedans (38), Improved Production U2L (47), Improved Production O2L (47), SuperSports (38), HQ Holdens (54), SuperKarts (60)

These races will be held in accordance with the 2019 CAMS Manual of Motor Sport and the relevant Sporting & Technical Regulations for 2019.

- a) In order to maximise track time and racing laps for all categories, ARDC in consultation with CAMS reserve the right to combine events. This will be done with due consideration to the State Championships and the categories concerned. Any such combination will be advised in the Race Meeting Schedule.
- b) Qualifying will take place on Saturday 26TH OCTOBER
- c) The Organiser reserves the right to postpone, abandon or cancel the Event in accordance with NCR 59.

8) LICENCE & MEMBERSHIP REQUIREMENTS

- a) Competitors must hold a current CAMS-Affiliated Car Club Membership unless they comply with (a) or (b) below.
- b) Competitors must hold a CAMS PCC (Provisional Clubman Circuit) or higher-grade licence unless they comply with (a) or (b) below.

Each Driver must hold a minimum of a CAMS Provisional Circuit competition licence unless noted otherwise against a particular event or specified otherwise in the Sporting Regulations for the relevant Championship/Cup/Series/Trophy/etc.

- or;
- (a) hold a MotorSport New Zealand competition licence and Tasman Visa valid for the event; or
- (b) hold a minimum of the highest-grade National Licence issued by a foreign ASN together with an authorisation issued by that ASN for the event; each such Driver and Competitor:
 - (i) shall be ineligible to score points in any Championship/Cup/Series/Trophy/etc. connected with the event; and
 - (ii) must receive an authorisation to compete from CAMS prior to the event;

9) AWARDS/PRIZES

Awards for this Event will be in the form of trophies and will be provided by the Organiser.

They will be awarded as per the relevant category Sporting Regulations, approved by CAMS for 2019, and in conjunction with the 2019 CAMS NSW Motor Race Championship Sporting Regulations Chapter 3 – Awards and Pointscores.

10) AUTOMATIC TIMING

The Organisers utilise an automatic timing system that requires all cars to be fitted with a Data 1 transmitter. Competitors must provide the transmitter. Transmitters are available from Dorian Industries, Factory 1, 29 Graham Court, Hoppers Crossing VIC, 3029. Phone: + 61 3 9931 1371.

11) PRIVATE PRACTICE AVAILABILITY

Sydney Motor Sport Park is available for Private Practice on Friday 25TH OCTOBER 2019. Entry for Private Practice can be online at

www.sydneymotorsportpark.com.au/competitor/ . The GST inclusive cost is \$190 per day or \$160 per day to members of the A.R.D.C.

The Closing Date for online entries is Monday 21ST OCTOBER 2019. Entry can be made on the day at a cost of \$240 per day, or \$210 per day to members of the A.R.D.C.

12) GARAGE AND PADDOCK ALLOCATION

The On-line Entry System allows the hiring of Garages and Carports. ARDC members are given 1st offer of Garages. Non-members Reserve a Garage initially. (If you do receive a Garage it is recommended that you bring your own padlock).

13) CREDENTIALS

All Competitors should enter Sydney Motor Sport Park via Gate A off Ferrers Road where a car pass and tickets will be available for collection. Proceed through Gate A and down to the Tunnel Entrance where car passes and admit passes will be checked. Then continue through the tunnel to your designated space in the Paddock or the Support Paddock.

Pit Lane wristband passes can be issued at Friday practice and will be valid all weekend.

If you need to withdraw your entry you must advise the ARDC in writing no later than 1700hrs on Monday 21ST OCTOBER 2019 COB 1700hrs. The ARDC will not consider refunds unless this requirement is strictly adhered to. A \$25.00 administration fee will be charged for ALL withdrawals. If a Competitor pays to attend Friday practice then suffers a mechanical failure which prevents them racing the ARDC will refund 50% of the race Entry Fee if advised in person or email or fax before 1700hrs Friday 25TH OCTOBER 2019.

14) TARGETED SCRUTINY

All vehicles must comply with the relevant requirements for their category. Targeted Scrutiny will be conducted at this Meeting. The Chief Scrutineer for the Event will determine which vehicles will be audited and those Competitors will be advised of a time in which the audit will occur at Event Documentation Scrutiny. A CAMS Vehicle Log Book must be presented. Competitors and Drivers must present their CAMS Affiliated Car Club Membership Card, CAMS licence and Log Book at Event Documentation Scrutiny.

All Competitors must wear apparel in compliance with Schedule D of the CAMS Manual of Motor Sport. All footwear, socks and gloves must comply with FIA 8856-2000 standard.

15) FUEL

Fuel must be in accordance with Schedule G of the current CAMS Manual.

98Ron, Elf Race 102 and commercial E85 fuel are available via bowser at all times. The bowsers accept all credit cards.

The maximum amount of fuel to be stored in each garage is 250 litres. Refuelling is not allowed in pit lane or in pit garages whilst participating in a race or session. Any refuelling done outside this period, must be done in the following manner;

16) INSURANCE

Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.

17) PROTESTS

Protests must be lodged in accordance with Part XII of the NCR.

18) ALCOHOL, DRUGS AND OTHER SUBSTANCES

Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.
